

# 2009 August Interim Housing Application

This application is for:

- students receiving College-Subsidized Summer Housing who wish to stay for August Interim, or
- students paying for Barnard Summer Housing who previously did not indicate they wish to stay for August Interim, or
- students living in CU Housing for the summer (who have a Fall assignment in a Barnard residence hall) who wish to stay for August Interim.

Students are eligible for August Interim housing (August 14 – September 5) only if they:

- a) are living in Barnard or Columbia Summer Housing for Summer Session 2 (through August 14)
- b) have a Fall 2009 housing assignment in a Barnard residence hall

Students who cancel their Fall 2009 housing assignment will cease to be eligible for August Interim housing. Students living in a Columbia residence hall for the Fall 2009 semester must apply for August Interim housing with CU Housing.

Students who stay for August Interim will be required to move from their Summer room into temporary housing (non-AC doubles) before moving to their Fall room in order to accommodate the cleaning schedule. Students will be required to move into and out of temporary housing with a minimum of 24 hours advance notice. Students who fail to move when required will be fined (minimum \$500) to have their belongings removed from campus. August Interim is not intended to provide storage space for students who do not plan to remain on campus during this time period.

**Cost:** August Interim costs \$880. Note: students who are eligible for early Fall move-in due to participation in NSOP, sports, or other approved reasons will be charged \$40 per night to bridge their summer & fall housing.

**Application Deadlines:** Applications are due to Residence Life and Housing (110 Sulzberger) no later than 4pm on Monday, June 22. Late applications, if approved, will result in an additional \$120 late application fee.

**Cancellation Deadline:** Requests to cancel August Interim housing before August 13 will result in a \$100 cancellation charge. Students who cancel on or after August 13 will not receive a refund of the August Interim charge (\$880).
