Several opportunities in this newsletter have deadlines in early January through February, so be mindful of the timing.

Featured Funder

American Chemical Society

The American Chemical Society is, according to its website, “the world’s largest scientific society.” Its mission “is to advance the broader chemistry enterprise and its practitioners for the benefit of Earth and its people. Our vision is to improve people’s lives through the transforming power of chemistry.” That mission translates, among other things, into \$20 million in research grants annually. The ACS has funded the research of several Barnard faculty. The following opportunities may be of interest to Barnard faculty.

Petroleum Research Fund Undergraduate Research and Undergraduate New Investigator Grants

These grants support the research of “established scientists and engineers at non-doctoral departments” and “new scientists and engineers who are faculty members at undergraduate research institutions,” respectively, and provide financial support for “students at those institutions to become involved in advanced research activities, in preparation for continued study in graduate school or employment.” **Deadline: March 15, 2019** <<more>> and <<more>>

Petroleum Research Fund New Directions Grants

“The New Directions Grants Program aims to stimulate a *new direction* of research for established faculty, and to support the careers of their student scientists and engineers.” **Deadline: March 15, 2019** <<more>>

Green Chemistry Grants

“A primary objective of the ACS Green Chemistry Institute® (ACS GCI) is to advance research in green chemistry by promoting funding, increasing opportunities, and developing information on the benefits of green chemistry.” In 2018, the program supported pharmaceutical grants in greener chromatography modalities and an ignition grant for green chemistry and engineering research. Both are currently closed, but we will keep an eye out for 2019 offering. <<more>>

Community Recognition Grants

“The American Chemical Society recognizes activities at the community level and provides grants to support programs that advance the public’s understanding of chemistry.” Most of these small grants (\$2,000 and under) support local sections to produce programming, such as Science Café. Deadlines vary. <<more>>

Frasch Foundation Grants

The Herman Frasch Fund for Chemical Research “award(s) grants to nonprofit incorporated institutions to support research in the field of agricultural chemistry which will be of practical benefit to the agricultural development of the United States.” The next competition will open in 2021. <<more>>

Teva Pharmaceuticals Scholars Grants

“The program is a philanthropic grant program that supports academic researchers (“Teva Scholars”) in the fields of organic and medicinal chemistry named in honor of Marc A. Goshko who was instrumental in initiating it.” The next cycle is expected to be announced in winter of 2020. <<more>>

The American Chemical Society also recognizes chemistry professionals through its [Fellows](#) program offers over 80 [awards](#) in a variety of chemistry fields for funding, invention, professional development, recognition, teaching, and travel. The Sponsored Research Office would be happy to provide a list of those for which Barnard faculty might be eligible.

Sage Advice for Competitive Proposals

Colorado State University’s “Principles of Effective Grantsmanship”

Colorado State University maintains a research administration information and news site, called [RAM](#), with monthly blog posts. In October and November Tricia Callahan, the Senior Research Education and Information Officer, ran a five-part series, “Principles of Effective Grantsmanship.” It covered topics from “[Resources for Research and Sponsored Programs](#),” which details resources available at CSU, to “[Write and Rewrite](#).” We will look closely at the latter in our next Newsletter. In between those two steps Callahan highlights several key components of grant submission that lay the groundwork for clicking “submit.”

In Part 2, “[Finding the Right Opportunity](#),” Callahan lists five helpful questions to ask program officers or oneself when deciding which requests for proposal would be the most worthwhile.

- “Do I meet all of the eligibility requirements?”
- What are the odds of success?
- What is the ratio of work to reward?
- How strongly does my project align with the sponsor’s mission, both present and future?
- How do my funding needs align with the sponsor’s timeline?”

Part 4 offers advice on “[Planning for Success](#)” and covers the often overlooked administrative work that goes into applying for grants. Early stage planning means recruiting support, including from colleagues and peers to help review your project, department chairs and research deans, the kind folks in Sponsored Research (ahem!), and I would add the Provost. Callahan provides a handy table for evaluating who might be most helpful at what stage of development.

Another handy to-do list appears in Part 2, and because it’s the view from 10,000 feet, I will add it here as a conclusion.

“Grant seeking is challenging and competitive. But, you can improve your chances considerably by going about it the right way. In sum, this entails:

1. Ensuring that the project is competitive and a good fit with the sponsor;
2. Starting early and reaching out for assistance;
3. Writing a concise, compelling narrative that helps the reviewer to do their job; and
4. Rigorously adhering to all guidelines.”

From the NSF

Statement from the Acting Assistant Director for Biological Sciences on Proposal Submission Limits

In a [November 15 letter](#), the Directorate of Biological Sciences announced, “Having listened to community concern and tracked the current low rate of submission, and following extensive internal consultation, BIO is lifting all PI or co-PI restrictions on proposal submission for FY 2019, effective immediately.” The Directorate will continue to maintain rolling deadlines on all solicitations.

NSF New PAPPG

NSF has announced that a revised version of the NSF [Proposal & Award Policies & Procedures Guide](#) (PAPPG) has been issued.

“The new PAPPG will be effective for **proposals submitted, or due, on or after January 28, 2019**. Significant changes include:

- Addition of Research.gov as an option for proposal preparation and submission, and proposal file updates;...
- Revision of resubmission guidelines for NSF programs that accept proposals at any time;
- Implementation of NSF’s policy on sexual harassment and other forms of harassment, or sexual assault;
- Specification that proposers are required to have a policy or code-of-conduct that addresses sexual harassment, other forms of harassment, and sexual assault, and that includes clear and accessible means of reporting violations of the policy or code-of-conduct. This policy or code-of-conduct must be disseminated to conference participants prior to attendance at the conference as well as made available at the conference itself;
- Emphasis on the importance of training faculty in the responsible and ethical conduct of research;...
- Numerous clarifications and other changes throughout the document.”

NIH – Human Subjects Research Questionnaire

This [NIH website](#) includes a decision tool that “can assist you with determining if your research involves human subjects, may be considered exempt from Federal regulations, or is not considered human subjects research.”

The Berggruen Institute USC Dornsife Fellowships

Deadline: January 2, 2019

“The Berggruen Institute seeks to encourage a deeper understanding of the great political, economic, social, and cultural transformations that are reshaping the human condition, in order to better inform practical responses. It organizes and supports inquiries that bring multicultural and interdisciplinary knowledge to questions of governance, of philosophy and culture, and of global restructuring including especially the role of China.

William T. Grant Foundation Research Grants

Deadline: January 9, 2019

“The research grants programs support high-quality field-initiated studies that are relevant to policies and practices that affect the lives of young people ages 5 to 25 in the United States. Research proposals are evaluated on the basis of their fit with a given focus area; the strength and feasibility of their designs, methods, and analyses; their potential to inform change; and their contribution to theory and empirical evidence.” [<<more>>](#)

National University of Singapore Isaac Manasseh Meyer Fellowship

Deadline: January 11, 2019

"The Fellowships are intended to provide opportunities for academics specializing in any area of arts and social sciences to visit and spend time at the Faculty of Arts and Social Sciences, conducting research and giving lectures and seminars. Fellows are expected to engage in collaborative research with faculty members. The typical duration of IMMF is one month or less. The IMMF is open to scholars in any area of the humanities and social sciences. Priority will be given to those who can contribute to the strategic areas of research of the Faculty with collaborative projects or projects leading to a major grant proposal." [<<more>>](#)

San José State University Steinbeck Fellowships

Deadline: January 2, 2019

"Yearlong residencies at San José State University in San José, California, which include a stipend of \$15,000 each, are given annually to fiction writers and creative nonfiction writers. The fellows will give one public reading each semester and must live in the San José area during the academic year." [<<more>>](#)

Leon Levy Center for Biography at The Graduate Center, CUNY, Biography Fellowships

Deadline: January 7, 2019

"The Leon Levy Center for Biography offers four resident fellowships at the Graduate Center for the academic year beginning each September. Awards include writing space, full access to research facilities, research assistance and a stipend of \$72,000. Fellows devote their time to their projects and participate in monthly seminars and the public events of the Leon Levy Center for Biography, including the annual lecture and the annual conference, and they are encouraged to join in the dynamic intellectual community of the Graduate Center." Ellen Meloy Fund Desert Writers Award

Deadline: January 15, 2019

"A prize of \$5,000 is given annually to enable a creative nonfiction writer 'whose work reflects the spirit and passions for the desert embodied in Ellen Meloy's writing' to spend creative time in a desert environment. Using the online submission system, submit up to 10 pages of creative nonfiction, a project description, and a one-page biography." [<<more>>](#)

National Endowment for the Humanities Digital Humanities Advancement Grant

Deadline: January 15, 2019

"Digital Humanities Advancement Grants (DHAG) support digital projects throughout their lifecycles, from early start-up phases through implementation and long-term sustainability. Experimentation, reuse, and extensibility are hallmarks of this grant category, leading to innovative work that can scale to enhance research, teaching, and public programming in the humanities. This program is offered twice per year. Proposals are welcome for digital initiatives in any area of the humanities. Through a special partnership, the Institute of Museum and Library Services (IMLS) anticipates providing additional funding to this program to encourage innovative collaborations between museum or library professionals and humanities professionals to advance preservation of, access to, use of, and engagement with digital collections and services." Permafrost Magazine University of Alaska Press Book Prize in Nonfiction

Deadline: January 15, 2019

"A prize of \$1,000 and publication by University of Alaska Press is given in alternating years for a book of poetry, fiction, or nonfiction. The 2019 prize will be given for a book of nonfiction. The Permafrost Book Prize in Nonfiction welcomes manuscripts from any writer, including non-US citizens, writing in English. Simultaneous submissions are

accepted, but we ask that you notify us immediately if your manuscript is accepted for publication elsewhere." <<more>>

Center for Italian Modern Art Fellowship Program

Deadline: January 27, 2019

"The Center for Italian Modern Art awards a number of fellowships each year to support the study of Italian modern and contemporary art by scholars at the master's, doctoral, and post-doctoral level. The program's intention is to bring together emerging scholars from diverse academic backgrounds in an interactive and collaborative environment at CIMA's New York location. Fellows pursue their own research, but also participate in the annual installation and the Center's activities. CIMA also offers a Travel Fellowship for scholars interested in studying in Italy, and an Affiliated Fellowship with the Civitella Ranieri to support an art historian's stay for six weeks at the residence in Italy. Citizens of all nationalities are eligible to apply." <<more>>

Academy of Motion Picture Arts and Science Film Scholars Program

Deadline: January 31, 2019

"Academy Film Scholars grants are awarded to previously published individuals who are pursuing significant new works of film scholarship. These grants fund research as well as academic and scholarly projects that elevate both filmmaking and film scholarship. Projects must address cultural, educational, historical, theoretical or scientific aspects of theatrical motion pictures. Applicants must have written and published at least one book of scholarship prior to applying." <<more>>

University of London, School of Advanced Study Institute of Philosophy Fellowship

Deadline: January 31

"The Institute welcomes applications from philosophers who wish to visit London, and can offer its own office space and other facilities.

Fellows are encouraged to take an active part in the life of the Programme, and in the many other philosophical activities in London. The Aristotelian Society holds its fortnightly meetings in Senate House, and the Royal Institute of Philosophy holds weekly meetings in nearby Gordon Square. Prospective fellows may apply for a visit of up to one year. Fellows may work in any area of philosophy." <<more>>

Humanities New York Action Grants

Deadline: February 1, June 1, October 1, 2019

"Up to \$5,000 to produce public-facing humanities projects that encourage audiences to reflect on their values, explore new ideas, and engage with others across New York State. These grants require organizations to demonstrate a match of at least one-to-one. These grants aim to: Connect audiences more deeply to the communities where they live and work. Solidify community partnerships and diversify audiences. Creatively employ the tools of the humanities to respond to issues and ideas capturing the imagination and passion of New Yorkers today." <<more>>

National Endowment for the Arts Art Works

Deadline: February 14, 2019

"Grants for organizations support exemplary projects in artist communities, arts education, dance, design, folk and traditional arts, literature, local arts agencies, media arts, museums, music, musical theater, opera, presenting and multidisciplinary works, theater, and visuals arts. We fund projects only. Projects may be large or small, existing or new, and may take place in any part of the nation's 50 states, the District of Columbia, and U.S. territories. Projects may consist of one or more specific events or activities." <<more>>

**Wabash Center
Project Grants**

Deadline: February 15, 2019

"The Wabash Center understands its grant projects as learning processes. Thus, as in other learning processes, a particular grant will design moments of exploration, discovery, learning, and response for those participating in the grant project. In building a grant project, the project director should think of the presenting pedagogical issue as that which needs exploration and interrogation, and the activities of the grant project as the means by which this exploration is done. The design should have an appropriate scaffold to facilitate learning and critical reflection, with moments of assessment built into the design so changes can be made, if necessary. It should also have a time of evaluative reflection at the end to assess what was learned during the course of the project." <<more>>

**Vermont Studio Center
Fellowships**

Deadline: February 15, 2019

"Our mission is to provide studio residencies in an inclusive, international community, honoring creative work as the communication of spirit through form." "We offer over 120 fellowships per year to artists and writers of outstanding talent. A fellowship covers the full cost of a VSC residency (some awards also include an additional stipend for travel/lost income/etc). At each of our three annual deadlines (February 15th, June 15th, and October 1st), our fellowship offerings change. In addition to some donor-driven awards with special eligibility requirements, there are always a number of general, merit-based VSC fellowships for which all applicants are considered." <<more>>

Deadline: Rolling

"On a bi-yearly basis, the Samuel Proctor Oral History Program grants a researcher with the Julian Pleasants Travel Award, designed to

promote cutting edge oral history research at the University of Florida and recognize innovative scholarship.... The award includes a stipend of \$1,000. Competition is open to graduate students, faculty, and independent scholars at UF and throughout the United States." <<more>>

**National Education Association Foundation
Learning and Leadership Grants**

Deadline: February 1, 2019

"Educators frequently need outside resources to engage in meaningful professional development due to limited district funding. Through our Learning & Leadership grants, we support the professional development of NEA members by providing grants to: Individuals to participate in high-quality professional development like summer institutes, conferences, seminars, travel abroad programs, or action research Groups to fund collegial study, including study groups, action research, lesson plan development, or mentoring experiences for faculty or staff. "Applicants for the Open Society Fellowship are invited to address the following proposition: New and radical forms of ownership, governance, entrepreneurship, and financialization are needed to fight pervasive economic inequality. This proposition is intended as a provocation—to stimulate productive controversy and debate—and does not necessarily represent the views of the Open Society Foundations. Applicants are invited to dispute, substantiate, or otherwise engage with the proposition in their submissions. Though the proposition deals with economic issues, those without an economics or business background are welcome to apply, provided they have a relevant project in mind.

Once chosen, fellows will work on projects of their own design and passion. At the same time, they are expected to take advantage of the intellectual and logistical resources of the Open Society Foundations and contribute meaningfully to the Foundations' thinking. Other funds are sometimes available in other fields, including the sciences. The book or article must be accepted by a peer-reviewed academic publisher. Some or all of the publication was influenced by participation in a University Seminar; a portion of the work was presented and discussed at a University Seminar, and that discussion affected the book." National Science Foundation

High-Risk Research in Biological Anthropology and Archeology

Deadline: Rolling

"Anthropological research may be conducted under unusual circumstances, often in distant locations. As a result the ability to conduct potentially important research may hinge on factors that are impossible to assess from a distance and some projects with potentially great payoffs may face difficulties in securing funding. This program gives small awards that provide investigators with the opportunity to assess the

feasibility of an anthropological research project. The information gathered may then be used as the basis for preparing a more fully developed research program. Projects which face severe time constraints because of transient phenomena or access to materials may also be considered." [<<more>>](#)

Beckman Center Fellowships**

"The Beckman Center offers fellowships on an annual cycle for scholars doing research in the history and social studies of chemistry and related sciences, technologies, and industries. Fellows are expected to participate in biweekly informal writing groups and give at least one lunchtime lecture. They also have the opportunity to take part in a variety of outreach activities while in residence at CHF. Early Career and Exploration Grants**

Deadline: January 9, 2019

"All proposed projects should be bold, innovative, and potentially transformative and have a primary focus in conservation, education, research, storytelling, or technology. Projects should also align to one of our three focus areas. We do not usually consider applications that support strictly laboratory or collections work.

Early Career Grants are designed to offer less experienced individuals an opportunity to lead a project." (\$5,000-\$10,000)

An Exploration Grant application is a request for funding by an experienced project leader in the areas of conservation, education, research, storytelling, and technology." (\$10,000-\$30,000)

As part of supporting a planet in balance, National Geographic offers Exploration grants that concentrate on certain key issues. Park City Mathematics Institute Summer
Research Session**

Deadline: January 15, 2019

"Complementing the highly structured Graduate Summer School, which is directed at younger mathematicians, the Research Program in Mathematics addresses the needs of mathematicians who are already carrying out research.
