American Psychological Association

“APA is the leading scientific and professional organization representing psychology in the United States.”

APA consists of 4 directorates aimed at advancing the 1) Education, 2) Practice, 3) Public Interest, and 4) Science of Psychology. Its 54 divisions “represent subdisciplines of psychology (e.g., experimental, social, or clinical) while others focus on topical areas such as aging, ethnic minorities or trauma. APA members, and even nonmembers, can apply to join one or more divisions which have their own eligibility criteria and dues. In addition, each division has its own officers, website, publications, email list, awards, convention activities and meetings.” Professionals can apply to join one or more divisions, each of which has its own eligibility criteria, dues, and grants, awards, and funding mechanisms, resulting in hundreds of potential opportunities for recognition. To help scholars, students, and practitioners wade through all the prospects, APA offers a robust search engine [here](#).

Division 2, The Society for the Teaching of Psychology, offers a Scholarship of Teaching and Learning Grant based on the Executive Committee’s annual theme. The 2018 themes are “(1) Scientific Literacy, (2) Psychology and Liberal Arts: Maintaining the integrity of liberal education in a rapidly changing world, and (3) Culture Across the Curriculum: How to teach a psychology of all people.” The APA site lists the deadline as November 2, 2018, but the Division 2 SoTL website still has the 2017 deadline of October 30. Also on the SoTL website, teachers of psychology can find information about an Excellence in Teaching Award, an Early Career Travel Grant, and Instructional Resource Awards.

Division 32, the Society for Humanistic Psychology, gives several recognition awards each year. APF offers the Carmi Harari Early and Mid-Career Awards for Inquiry, Application, and Social Action and a few for lifetime achievement. Deadlines for nominations are November 1, 2018. [<<more>>](#)

Division 49, the American Psychological Foundation, describes itself as “a grant-making foundation that funds early career psychologists and graduate students using psychology to solve important problems and improve people’s lives,” but it lists Fellowships, Grants, and Awards for all career levels, including in Clinical Psychology. It “makes grants in the following areas:

- Understanding the connection between behavior and health.
- Reducing stigma and prejudice.
- Preventing violence.
- Addressing the long-term psychological needs in the aftermath of disaster.
- Treating serious mental illness.
- Studying gifted children and adolescents.
- Examining human reproductive behaviors.
- Exploring child psychology.” [<<more>>](#)

Sage Advice for Competitive Proposals

Since the inception of Sage Advice, we've offered a few articles and perspectives on tips and how-tos. This time we look at a list of what NOT to do in your grant proposal. On January 4, the *Chronicle of Higher Education* ran "10 Common Grant-Writing Mistakes," written by Jude P. Mikal and Gina Rumore, part of the University of Minnesota's research development staff.

Mikal and Rumore point to follies such as "fail[ing] to adapt it to the stated priorities of the organization they're asking for money," submitting "vague" or contradictory summary pages, and "promising too much or too little."

One we thought was particularly important to point out is "No. 3: 'The loner.'...In the past, grants were often viewed as a one-person show — a single investigator assisted by his or her graduate students. Not anymore. Today agencies and foundations tend to value projects that require cross-disciplinary participation. Incorporating novel research perspectives requires one or more co-investigators to ensure those perspectives are thoroughly integrated." The need for collaboration is particularly common in the sciences and social sciences, where projects grapple with quantities of data or complex instruments. In those fields and in the humanities, interdisciplinary projects are attracting more attention from funders, as are those that incorporate technology or unconventional media as part of dissemination. Indeed, several funders such as the NSF and Mellon Foundation, have grants designated solely for digitization, collaboration, and/or interdisciplinary investigation.

National Endowment for the Humanities Fellowships

Deadline: April 11, 2018

"Fellowships support individuals pursuing advanced research that is of value to humanities scholars, general audiences, or both. Recipients usually produce articles, monographs, books, digital materials, archaeological site reports, translations, editions, or other scholarly resources in the humanities." [<<more>>](#)

National Endowment for the Humanities Mellon Fellowships for Digital Publications

Deadline: April 11, 2018

"Through NEH-Mellon Fellowships for Digital Publication, the National Endowment for the Humanities and The Andrew W. Mellon Foundation jointly support individual scholars pursuing interpretive research projects that require digital expression and digital publication.

To be eligible for this special opportunity, an applicant's plans for digital publication must be essential to the project's research goals. That is, the project must be conceived as digital because the nature of the research and the topics being addressed demand presentation beyond traditional print publication. Successful projects will likely incorporate visual, audio, and/or other multimedia materials or flexible reading pathways that could not be included in traditionally published books, as well as an active distribution plan." The Library Company of Philadelphia Short-Term Fellowships

Deadline: March 1, 2018

"The Library Company of Philadelphia and The Historical Society of Pennsylvania will jointly award approximately twenty-five one-month fellowships for research in residence in either or both collections during the academic year 2018-2019. These two independent research libraries, adjacent to each other in Center City Philadelphia, have complementary collections capable of supporting research in a variety of fields and disciplines relating to the history of America and the Atlantic world from the 17th through the 19th centuries, as well as Mid-Atlantic regional history to the present." The Library Company Philadelphia Program in African American History Mellon Scholars Research Fellowship

Deadline: March 1, 2018

Folger Shakespeare Library Short Term Fellowships

Deadline: March 1, 2018

"In addition to being the world's largest Shakespeare collection, the Folger is home to major collections of other rare Renaissance books, manuscripts, and works of art. Located a block from the US Capitol, the Folger serves a wide audience of scholars, visitors, teachers, students, families, and theater- and concert-goers." ... "We welcome applications from archivists, creative artists, curators, librarians, performers, and playwrights whose research will benefit from focused engagement with the Folger collections." <<more>>

Ucross Foundation Residency Program

Deadline: March 1, 2018

"The Ucross Foundation Residency Program [in Sheridan, Wyoming] offers the gift of time and space to competitively selected individuals working in all artistic disciplines. The Foundation strives to provide a respectful, comfortable and productive environment, freeing artists from the pressures and distractions of daily life." <<more>>

ArtsCONNECT

Deadline: March 2, 2018

"ArtsCONNECT provides funding for mid-Atlantic-based presenters (New Jersey, Delaware, Maryland) working collaboratively to engage a performing artist or ensemble. The program aims to develop and deepen relationships among the region's presenters, helping build a more sustainable touring environment for artists and ensembles. The supported tours include performances as well as community engagement activities that enhance the performance experience, and offer meaningful exchanges between touring artists and a presenter's community. The program provides support for projects in which at least three performing arts

presenters from two different states work collaboratively to present a touring solo artist or ensemble. The tours include performances as well as activities such as artist discussions, lecture demonstrations, master classes, and workshops designed to build greater appreciation for the work of the touring artist or ensemble. The program also is designed to develop and deepen relationships among the regions presenters in order to build a more sustainable touring environment for professional performing artists." <<more>>

American Philosophical Society Digital Humanities Fellowship

Deadline: March 2, 2018

"The American Philosophical Society offers fellowships to scholars working to interpret archival materials through emerging technologies." ... "Scholars, including graduate students, at any stage of their career may apply. Special consideration will be given to proposals that present APS Library holdings in new and engaging ways. Examples include (but are not limited to) projects that incorporate timelines, text analytics, network graphs, and maps." <<more>>

Kierkegaard Library at St. Olaf College Summer Fellows Program for Research in Residence

Deadline: March 15, 2018

"The Kierkegaard Library offers unpaid research fellowships to serious scholars for two to eight weeks in duration during the months of June and July. Acceptance includes extensive access to the Kierkegaard Library and the opportunity to use the other libraries and facilities of St. Olaf College. Free housing on campus is provided; all other costs are the responsibility of the scholar. Participants of the program include students at graduate level and seasoned scholars. Advanced undergraduates are encouraged to apply to the Young Scholars Program. The program entitles scholars to use the resources of the Kierkegaard Library while attending required activities that include: attend guest lectures, peer presentations,

and participate in scholar seminars twice a week. The atmosphere encourages sharing of academic thoughts and opinions in relation to Kierkegaard's writing and ideals." <<more>>

American Historical Association J. Franklin Jameson Fellowship

Deadline: April 1, 2018

"The J. Franklin Jameson Fellowship in American History is offered annually by the John W. Kluge Center at the Library of Congress and the American Historical Association to support significant scholarly research in the collections of the Library of Congress by scholars at an early stage in their careers in history." <<more>>

Deadline: April 1, 2018

"The Digital Resources program is intended to foster new forms of research and collaboration as well as new approaches to teaching and learning. Support will also be offered for the digitization of important visual resources (especially art history photographic archives) in the area of pre-modern European art history; of primary textual sources (especially the literary and documentary sources of European art history); for promising initiatives in online publishing; and for innovative experiments in the field of digital art history." <<more>>

Kettering Foundation Katherine W. Fanning Residency in Journalism & Democracy

Deadline: March 1, 2018

"The Kettering Foundation invites journalists and scholars of journalism from around the world to spend up to six months working with us in Dayton, Ohio, to explore the role of journalism in a democratic society and the obligations of journalists to democratic public life. While at the foundation, residents are expected to work with Kettering's staff on the foundation's ongoing research in this area. Work will include literature reviews related to the foundation's program areas, exploration of the role of a deliberative public in the political work of communities domestically and internationally, and participation in workshops and other meetings related to the foundation's research." <<more>>

American Political Science Association Small Research Grants

Deadline: April 1, 2018

"The APSA Small Research Grant Program supports research in all fields of political science. The intent of these grants is to provide funding opportunities for research conducted by political scientists not employed at PhD-granting departments in the field, or who are in non-tenure track or contingent positions ineligible for departmental funding." <<more>>

Access Group Center for Research & Policy Analysis Legal Education Diversity Pipeline Grant Program

Deadline: April 1, 2018

"To be considered for funding, a proposal must seek to improve directly access to legal education for historically underrepresented minority students and students from economically disadvantaged backgrounds. Measurement and evaluation are essential components for demonstrating the effectiveness and scalability of interventions, and are key factors when deciding

Wilson Center Kennan Institute Scholarships and Fellowships

Deadline: March 1, 2018

"The Kennan Institute seeks fellowship applicants from diverse, policy-oriented sectors such as media, business, local government, law, civil society, and academia to examine important political, social, economic, cultural, and historical issues in Russia, Ukraine, and the region. Among the aims of the new fellowships are to build bridges between traditional academia and the policy world, as well as to maintain and increase collaboration among researchers from Russia, Ukraine, the U.S., and around the globe.... Title VIII Scholarships (Research, Summer, and Short-term) are available to scholars who are U.S. Citizens; ... George F. Kennan and Billington Fellowships are not limited by citizenship."

Gerald R. Ford Presidential Foundation Research Travel Grants Program

Deadline: March 1, 2018

"The Gerald R. Ford Presidential Foundation awards grants of up to \$2,200 each in support of research in the holdings of the Gerald R. Ford Library. A grant defrays travel and living expenses of a research trip to the Ford Library. Overseas applicants are welcome to apply, but they will be responsible for the costs of travel between their home country and North America. The grants only cover travel within North America. Library collections focus on Federal policies, U.S. foreign relations, and national politics in the 1960s and 1970s. There are earlier and later materials depending upon your topic." <<more>>

American Political Science Association Small Research Grant Program

Deadline: April 1, 2018

"The APSA Small Research Grant Program supports research in all fields of political science. The intent of these grants is to provide funding opportunities for research conducted by political scientists not employed at PhD-granting departments in the field, or who are in non-tenure track or contingent positions ineligible for departmental funding."

LANGUAGE AND AREA STUDIES

International Institute for Asian Studies Fellowships

Deadline: March 1, 2018

"IIAS is an institute that actively promotes innovative research and seeks the interconnection between academic disciplines. In doing so, we are particularly looking for researchers focusing on the three IIAS clusters 'Asian Cities', 'Asian Heritages' and 'Global Asia'. However some positions will be reserved for outstanding projects in any area outside of those listed. Applications that link to more than one field are also welcome." <<more>>

Society for the Study of French History Visiting Scholars Scheme

Deadline: March 23, 2018

"The Society will to consider providing up to £2,000 per year to support a visit by a foreign scholar actively working on French history to UK or Irish HE institutions. The objective is to foster international contact between scholars of the subject and the UK's role within it. The scheme is open to bona fide scholars actively working at, or with a clearly defined relationship to, a recognised institute of higher education outside the UK. The proposed host institution in the UK or the Irish Republic must demonstrate that it is committed to underwriting the essential costs of the visit in terms of the provision of office accommodation, academic support and, where appropriate, contributions to the costs of lodging and

transport. Applicants themselves must show that they have a clear programme of research which will involve collaboration with scholars in the UK." <<more>>

Institute of Turkish Studies Grants in Turkish and Ottoman Studies for Publication of Scholarly Books and Journals, Academic Conferences, and Teaching Aids

Deadline: March 30, 2018

"The Institute of Turkish Studies (ITS) will offer grants and fellowships in the field of Ottoman and Modern Turkish Studies to graduate students, post-doctoral scholars, universities, and other educational institutions through its Grants Program for the 2018-2019 academic year. The annual budget for the Grants Program has been significantly expanded and ITS encourages qualified applicants to apply for its grants."

- "Grants for the Publication of Scholarly Books and Journals to cover part of the publication costs of scholarly books and journals in the field of Turkish Studies to be published in the U.S."

National Institutes of Health R13, U13 Conference Grants and Conference Cooperative Agreements

Deadline: Permission to submit by March 1, 2018.

Deadline for application by April 12, 2018

"The NIH ICs each have different scientific missions, as well as program goals and initiatives that evolve over time. In order to promote the

most efficient use of NIH funds towards meeting the mission and program goals of the ICs, each conference grant application is required to contain a permission-to-submit letter from one of the participating ICs (see IC Contact and Special Interests website). Applicants are urged to initiate contact well in advance of the chosen application receipt date and no later than 6 weeks before that date. Applicants should inquire about IC-specific program priorities and policies in regards to conference grants. Please note that agreement to accept an application does not guarantee funding." <<more>>

American Psychological Association Ezra Katz Rosen Fund

Deadline: March 1, 2018

"The Esther Katz Rosen Fund was established in 1974 by a generous bequest intended to support '...activities related to the advancement and application of knowledge about gifted children.'

Rosen Fund grants:

- Enable and enhance development of identified gifted and talented children and adolescents.
- Encourage promising psychologists to continue innovative research and programs in this area.

Support will be provided for activities on the advancement and application of knowledge related to identified gifted and talented children and adolescents, such as:

- Research.
- Pilot projects.

American Psychological Foundation Visionary Grants (for early career)

Deadline: April 1, 2018

"The APF Visionary Grants seek to seed innovation through supporting research, education and intervention projects and programs that use psychology to solve social problems in the following priority areas:

- Applying psychology to at-risk, vulnerable populations (e.g. serious mental illness, returning military, those who are incarcerated or economically disadvantaged)
- Preventing violence
- Understanding the connection between

behavior and health (e.g. wellness, diabetes, obesity)

- Understanding and eliminating stigma and prejudice (e.g. race, gender, sexual orientation, religion, age, disability and socioeconomic status)

Preference will be given to pilot projects that, if successful, would be strong candidates for support from major federal and foundation funding agencies, and “demonstration projects” that promise to generalize broadly to similar settings in other geographical areas and/or to other settings.” <<more>>

Society for the Advancement of Behavioral Analysis International Development Grants

Deadline: March 1, 2018

"Two to four \$1,000 International Development Grants will be distributed annually to persons or organizations interested in developing behavior analysis internationally. In order to promote behavior analysis on a worldwide scale, we hope to increase opportunities for people and organizations that do not have the necessary resources to expand important information and knowledge." <<more>>

McKnight Foundation Memory and Cognitive Disorders Award

Deadline: March 26, 2018

"We are interested in proposals that address memory or cognition under normal and pathological conditions. This includes proposals that address mechanisms of memory or cognition at the synaptic, cellular, molecular, genetic or behavioral level in animals, including humans. We are particularly interested in proposals that incorporate fundamentally new approaches, as well as those that involve human experimentation. Collaborative and cross-disciplinary applications are encouraged."

From the NSF

The NSF offers wonderful grants conferences for

faculty researchers. You can see the [Fall 2017 presentations here](#) and/or keep an eye out for registration information for the Spring 2018 Conference in Detroit on June 4-5 [here](#). Take note, though, since registration slots for these NSF conferences are typically filled within an hour after they're posted!

"Why attend an NSF Grants Conference?"

- Are you a new faculty member... or researcher?
- Do you want to know about the current state of NSF funding?
- Do you need to gain insight into new and current policies and procedures?
- Would you benefit from learning about funding opportunities from the program officers representing each NSF directorate?

If you answered “yes” to any of these questions, get notified about [NSF’s] next Grants Conference.” Research funding for US universities up for first time in five years in 2016 *Non-profit organizations and other funding sources also funneled more into academic research.*

“US federal funding of academic research and development (R&D) increased between 2015 and 2016 for the first time since 2010, according to data from the US National Science Foundation (NSF).

“When adjusted for inflation, federal funding for academic R&D rose by 1.4% during that period, former President Barack Obama’s last year in office, the data show. The NSF examined 640 US institutions that reported at least US\$1 million in R&D outlays during their previous fiscal year.”
