Featured Funder: Alfred P. Sloan Foundation

The Alfred P. Sloan Foundation primarily supports research and education related to science, technology, engineering, mathematics, and economics, and believes that "these fields—and the scholars and practitioners who work in them—are chief drivers of the nation's health and prosperity." The Sloan Foundation accepts and evaluates requests for funding throughout the year through their grant application process, and prioritizes funding projects that "have a high expected return to society, exhibit a high degree of methodological rigor, and for which funding from the private sector, government, or other foundations is not yet widely available."

To apply for a grant, the Foundation first encourages you to become familiar with the Foundation's programs. The Foundation hosts a number of grant opportunities that span program areas, including: Research, Higher Education, Technology, Public Understanding, and the New York City Program. While some programs, such as the Higher Education program, support institutional grants, programs like the Research Program are the Foundation's bread and butter for supporting faculty research projects. To clarify which Research programs welcome unsolicited inquiries, we've detailed the program's goals and current submission status below:

The Foundation's **Research Program** funds research in the following areas:

- ⇒ Economics: "To provide public goods, including fundamental research, conceptual breakthroughs, and technical advances, that inclusively strengthen and accelerate U.S. economic progress." Currently accepting inquiries.
- ⇒ Energy and Environment: "To inform the societal transition toward low-carbon energy systems in the United States by investigating economic, environmental, technological, and distributional issues." *Currently accepting inquiries*.
- ⇒ <u>History of Science & Technology</u>: "To advance our understanding of the historical context of scientific research and inform current and future research, policy, and institutional practice." *Currently accepting inquiries*.
- ⇒ <u>Matter-to-Life</u>: "To sharpen our scientific understanding of the physical principles and mechanisms that distinguish living systems from inanimate matter, and to explore the conditions under which physical principles and mechanisms guide the complexification of matter towards life." *Currently accepting inquiries*.
- ⇒ Sloan Digital Sky Survey: "To accelerate discoveries in astronomy and astrophysics through the support of an all-sky spectroscopic observation program that uses telescopes in both hemispheres to comprehensively map the night sky, examine the history and structure of the universe, and probe the physics of black holes." Please note that this program "does not accept unsolicited letters of inquiry. Scholars interested in participating in the Sloan Digital Sky Survey should contact the SDSS directly."
- ⇒ Small-Scale Fundamental Physics: "To discover new fundamental physics." Please note that the Foundation is "not currently accepting grant applications in Small-Scale Fundamental Physics. Pending evaluation of the outcomes of currently supported projects, additional grantmaking is anticipated in 2026."

After learning more about the Foundation's funding priorities and identifying a relevant program, the Foundation welcomes you to submit a Letter of Inquiry by email to the corresponding program director. In addition to their year-round grant application process, the Foundation currently has two open-calls available:

- ⇒ Letters of Inquiry on Interdisciplinary Social Science Research on Energy System Interactions in the United States: "Grants of \$500,000 \$1,000,000 to be made for interdisciplinary social science research on energy system interactions the United States, led by early- and mid-career scholars." | Deadline: March 25, 2025
- ⇒ Metascience and Al Postdoctoral Fellowships: "Grants of up to \$250,000 (USD) over up to two years will be awarded to social sciences and humanities postdoctoral researchers who study the implication of Al for Science." | Deadline: April 10, 2025

Recently, we completed a proposal that required our entire team's combined expertise, and we anticipate more collaborative projects in the future. One of our most productive ways to connect with faculty is through individual interviews, and in these interviews, we include as many of our team members as possible. Faculty get an opportunity to meet the team, and we get the pleasure of learning more about your research interests, projects, and funding needs, allowing us to identify the most suitable funding opportunities for your work. Including as much of our team in individual interviews helps ensure faculty receive the most well-rounded support possible, and also helps us prepare to rise to the occasion when collaborative projects present themselves. What does this mean for reaching out to our team? There really is no wrong way to reach out to us! Whether you contact one or all of us, we'll make sure it gets to the people best fit to support you with your project or funding needs. That being said, if you'd like to simplify the process of reaching out, we offer several straightforward options:

History of Philanthropy: Origins of the National Institutes of Health (NIH)

Last issue was meant to be part of a nice, long series of articles on the history of philanthropic tax law, but a few things have happened in the grants world since then. (Maybe you've heard!) Inspired by recent events, I've decided to switch gears and talk about the history of our federal research agencies. I'll return to tax law, but in the meanwhile, let's turn to the origins of the National Institutes of Health (NIH).

If you take the long view, the NIH began in 1798, when the young United States founded the Marine Hospital Service (MHS) to provide medical care for sailors. This wasn't an entirely altruistic decision. Sailors often brought back diseases from distant locales and as the years wore on, officials became more and more concerned with preventing epidemics. As it happened, the latter half of the 19th century was also a period of exciting advances in germ theory. In 1847, Ignaz Semmelweis had discovered that having doctors wash their hands in water mixed with lime before attending women in childbirth dramatically reduced maternal mortality, while in 1861 Louis Pasteur provided the key for understanding why infections occurred with his work on germ theory. In the 1880s, the German scientist Robert Koch was busy inventing the petri dish and using it to discover the causes of cholera and tuberculosis, among others. Eager to forestall epidemics, in the 1880s, Congress decided to make the MHS officially responsible for examining incoming sailors to prevent the spread of diseases such as cholera and yellow fever. Convinced in turn that these new advances in germ theory would help them prevent outbreaks, the MHS tasked Joseph J. Kinyoun in 1887 with setting up the very first national laboratory, known at the time as the United States Hygienic Laboratory and located in Staten Island. This was the predecessor of the National Institutes of Health.

Kinyoun was young for the job, only 27 at the time. He was born in 1860 in East Bend, North Carolina, though his family relocated to Missouri after their home was burnt down during the Civil War. He learned medicine by studying alongside his father, who was a general practitioner. He went on to earn an M.D. from Bellevue Medical College in 1882, then worked as a postdoctoral fellow in Carnegie Labs studying cholera and bacteriology more generally. He rounded out his education by working in Robert Koch's laboratory in Berlin, before taking a job with the MHS as an assistant surgeon, before moving on to running the laboratory. Kinyoun worked as both a researcher, studying the etiology of infectious diseases such as cholera, yellow fever, and smallpox, and as a public health authority, advocating vaccines and quarantines. One disease preoccupied him at that time, though—the bubonic plague.

The so-called <u>Third Plague Pandemic</u> was raging in Asia at the time. The first plague was the <u>Plague of Justinian</u>, which swept through the Byzantine Empire in 541-549 C.E., killing an unknown number of people. (Estimates range from 25 million to 100 million.) The second plague was the Black Death, which killed between 75 and 100 million people in the 1340s and following decades. The third plague started in 1855 in Yunnan, China, and killed somewhere between 12-15 million people until it was finally declared over in the 1950s. There are different theories about how it spread, <u>with some attributing it to the movement of troops</u> against Muslim rebels during <u>the Panthay Rebellion</u> in Yunnan, and others attributing it to the opium trade. Whatever the source, by the 1890s it had reached Hawaii and Kinyoun was worried that California was next.

His superiors were worried as well and transferred him to San Francisco in 1899. Kinyoun had, in theory, several key advantages in heading off the plague. First, scientists had finally discovered what caused it, isolating the *yersinia pestis* bacterium and making the all-important link to the fleas carried on rats. Second, he had the authority to quarantine ships in San Francisco. Yet when the plague finally arrived, political obstacles prevented him from effectively limiting its spread.

The problem was that the California governor, along with local officials, were deeply worried that rumors of plague would crater San Francisco's economy. The quarantine measures they were willing to take were limited and targeted people of Asian descent, such as banning people from leaving Chinatown until a lawsuit claiming that the quarantine violated the civil rights of the inhabitants overturned the quarantine. Mostly, though, officials denied the plague and launched a smear campaign against Kinyoun, claiming that he had fabricated the whole epidemic as part of an effort to increase his funding or that he had originated the plague by releasing his lab monkeys into the city. Eventually, beaten down and fearing for his safety, Kinyoun resigned and went into private practice.
