Terms and Conditions

- **A drop or change of a dining plan will not be accepted after the fourth day of each semester (September 7, 2012 and January 25, 2013). Charges will be prorated during this period. A Meal Plan Adjustment Form must be completed with the Barnard Bursar.**
- All Columbia students who are required to be on a meal plan may select Barnard's Platinum Plan (19 meals per week) to satisfy the mandatory meal requirement set forth by Columbia University.
- When dropping a meal plan, any remaining meal plan points are forfeited.
- Any meal plan points remaining at the end of the Fall semester may be carried over to the Spring semester providing the student remains enrolled in a Barnard meal plan during the Spring semester. Any meal plan points remaining at the end of the Spring semester are forfeited.
- In order to be eligible for the Barnard "Wrap Around Plan," a student must first be enrolled in a mandatory meal plan offered by Columbia University. The "Wrap Around Plan" provides up to 27 Shabbat meals per semester. Unused meals do not carry over from the Fall to the Spring semester.
- The "Wrap Around Plan" provides Shabbat meals and may not be used for other meals or services provided by Barnard College.
- I understand that by signing this contract, I am authorizing the College to enroll me in the meal plan specified above. I agree to be liable for the plan unless I cancel it in writing on the Barnard College Meal Plan Adjustment Form prior to the start of the semester. If I do not cancel it prior to the semester and if I default on my payment, the College may disclose that I have defaulted, along with relevant information to credit reporting agencies. I understand that the College reports delinquent accounts to a collection agency. I agree to pay any costs of collection including, without limitation, interest, penalties, collection agency costs, court costs, and attorney fees. Collection costs can be up to 40%. This agreement applies to any and all amounts due to the College now and in the future.
